3. The Bidders/Fabricators must have experience of successfully completing Fabrication and Supply of Steel Parts for minimum 5 (five) Trail Bridges within last 5 (five) years. New fabricators may apply in joint venture with an eligible firm having the required experience. Fabricators who are not enlisted by DoLI may also apply. However, bids of such fabricators shall be considered responsive only in case fabricators fulfil the requirements.
4. Sealed Quotations must be submitted through PPMO website www.bolpatra.gov.np/egg on or before **12:00 hours** on **07 January, 2022**. Quotation received after this deadline shall not be accepted.
5. Quotations must be valid for a period of **45 days** after opening of Sealed quotations and must be accompanied by Cash Security or Bank Guarantee, amounting as mentioned above which shall be **valid for 30 days** beyond the validity period of the bid. If the bidder wishes to deposit Bid Security as cash should deposit at Account name **Ga-3-1-CHHATRAKOT GA.PA.
