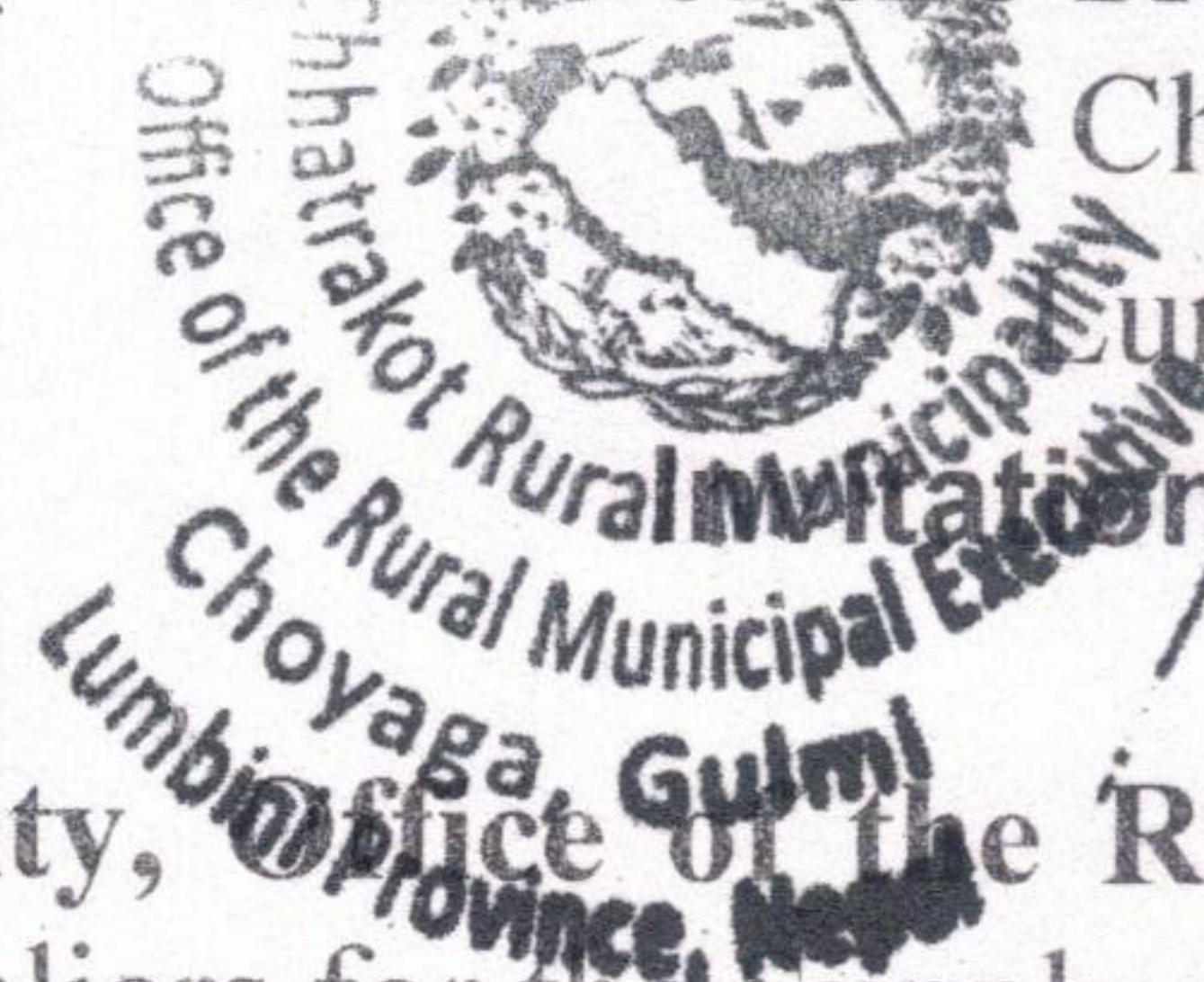

Quotations must be valid for a period of **45 days** after opening and must be accompanied by Cash Security or Bank Guarantee, amounting as mentioned above which shall be **valid for 30 days** beyond the validity period of the bid. If the bidder wishes to deposit Bid Security as cash should deposit at Account Name **GA-3-1-CHHATRAKOT GA.PA.
