4. Sealed bids must be submitted to the Office of Chhatrakot Rural Municipality, Chhatrakot-3, Gulmi by hand/courier on or before 12:00 Noon on 2075/08/28. Bids received after this deadline will be rejected.
5. The bids will be opened in the presence of Bidder's representatives who choose to attend at 01:00 PM on 2075/08/28 at the Office of Chhatrakot Rural Municipality, Chhatrakot-3, Gulmi.
6. Bids must be valid for a period of 90 days from the date of bid opening and must be accompanied by a bid security issued by "A" class Commercial Bank approved by Nepal Rastra Bank confirming to standard format as specified in bid document, amounting to a minimum of NRs. 1,25,000 (in words Rupees One Lakh Twenty Five Thousand), which shall be valid for 30 days beyond the validity period of the bid.
7. Pre-bid meeting shall not be held.
8. If the last date of purchasing and/or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
9. If the bidder does not manufacture or produce the goods and it offers to supply the desired goods shall submit the manufacturer's authorization or letter of authorized dealer of desired goods using the form included in Section IV.
10. The Purchaser Reserves the right to accept or reject, wholly or partly any or all the bids without assigning any reason, whatsoever.
11. Other mandatory information shall be as per prevailing PPA and PPR.
