- 5. Electronic bids must be submitted through PPMO website www.bolpatra.gov.np/egp on or before 23 September, 2021, 12:00 noon. Bids received after this deadline will be rejected.
- 6. The bids will be opened in the presence of Bidders' representatives who choose to attend at 23 September, 2021 13:00 hours at the office of Chhatrakot Rural Municipality, Choyaga, Gulmi, Lumbini Province, Nepal.
- 7. Bids must be valid for a period of 90 days after bid opening and must be accompanied by a bid security or scanned copy of the bid security in .pdf format in case of e-bid, amounting as mentioned below, which shall be valid for 30 days beyond the validity period of the bid. If the bidder wishes to deposit Bid Security as cash should deposit at GA-3-DHARAUTI KHATA 1170000004GE maintained at Century Commercial Bank Ltd., Chhatrakot Branch and the scanned copy (pdf format) of the Bank deposit voucher shall be uploaded by the bidder at the time of electronic submission of the bids...
